DECLARATORY JUDGMENT

For the reasons set forth in the Memorandum Decision on Action  
For Declaratory and Injunctive Relief issued this date, IT IS  
HEREBY ORDERED, ADJUDGED AND DECREED AS FOLLOWS:

1. This court confirms its original and exclusive  
jurisdiction over Debtors' cases under 11 U.S.C. § 1334(a) and  
Debtors' rights to assume or reject executory contracts under 11  
U.S.C. § 365, as core proceedings under 28 U.S.C. 157(b)(2).

1           2. Included in the foregoing paragraph are power purchase  
2 contracts between and among either or both Debtors and  
3 counterparties to any such contracts.

4           3. The Federal Energy Regulatory Commission does not have  
5 concurrent jurisdiction, or any jurisdiction, over the  
6 determination of whether any rejections of power purchase contracts  
7 by either Debtor should be authorized.

8           4. Debtors do not need approval from thereto reject any of  
9 their power purchase contracts.

10           5. Any determinations of the Federal Energy Regulatory  
11 Commission contrary to the provisions of Paragraph 3 and 4, above,  
12 in *NextEra Energy, Inc. V. Pac. Gas and Elec. Co.*, 167 FERC ¶  
13 61,096 (2019) at Para 13, *NextEra Energy, Inc. v. Pac. Gas and*  
14 *Elec. Co.*, 166 FERC ¶ 61,049 (2019); *Exelon Corp. v. Pac. Gas and*  
15 *Elec. Co.*, 166 FERC ¶ 61,053, or otherwise, are void, of no force  
16 and effect and not binding on this court of either Debtor.
