2 Corporation and Pacific Gas and Electric Company, as debtors and debtors in possession  
3 (the “**Debtors**”) in the above-captioned chapter 11 cases (the “**Chapter 11 Cases**”), each filed a  
4 voluntary petition for relief under chapter 11 of title 11 of the United States Code (the “**Bankruptcy**  
5 **Code**”) with the United States Bankruptcy Court for the Northern District of California (San  
6 Francisco Division) (the “**Bankruptcy Court**”).

7           **PLEASE TAKE FURTHER NOTICE** that the Bankruptcy Court will hold a hearing on  
8 January 14, 2020 at 10:00 a.m. (Pacific Time) (the “**Omnibus Hearing**”) in the courtroom of the  
9 Honorable Dennis Montali, United States Bankruptcy Judge, Courtroom 17, 16th Floor, 450  
10 Golden Gate Avenue, San Francisco, California 94102.

11           **PLEASE TAKE FURTHER NOTICE** that, in addition to any other matters scheduled for  
12 the Omnibus Hearing, the Bankruptcy Court is scheduled to hear the *Omnibus Objection of the*  
13 *Official Committee of Tort Claimants (Substantive) to No Liability Claims Filed by the Department*  
14 *of Homeland Security / Federal Emergency Management Agency (Claim Nos. 59692, 59734 &*  
15 *59783)* (the “**Claim Objection**”).

16           **PLEASE TAKE FURTHER NOTICE** that any oppositions or responses to the Claim  
17 Objection must be in writing, filed with the Bankruptcy Court, and served on the counsel for the  
18 TCC at the above-referenced addresses so as to be received by no later than **4:00 p.m. (Pacific**  
19 **Time) on December 31, 2019**. Any oppositions or responses must be filed and served on all  
20 “Standard Parties” as defined in, and in accordance with, the *Amended Order Implementing Certain*  
21 *Notice and Case Management Procedures* entered on May 14, 2019 (EFC No. 1996) (“**Case**  
22 **Management Order**”). **Any relief requested in the Claim Objection may be granted without**  
23 **a hearing if no opposition is timely filed and served in accordance with the Case Management**  
24 **Order**. In deciding the Claim Objection, the Court may consider any other document filed in these  
25 Chapter 11 Cases and related Adversary Proceedings.
